#### **UNIVERSITY FOCUS**

## Report: 4.01 – University Focus – Research

Vice President for Research, Dr. Erin Rothwell, noted she was grateful for the opportunity to present the VP for Research's Strategic Plan. VP Rothwell provided background on the University of Utah Research Office, gave a detailed presentation on the research enterprise and responded to questions from Trustees. Summary information is noted below:

## Background -

- 83,000 employees research activities funds for jobs
- \$248M in salaries are supported by research
- \$28M spent in Utah for research-related goods and services
- \$32M in state and local taxes from salaries supported by research

Last year the U reached a milestone of \$768M in research funding with more than 3,000 funding awards to over 1,100 researchers. Most of the funding came from agencies such as National Science Foundation, Department of Energy, and National Institutes of Health. In the future, VP Rothwell noted the U will need to diversify its research portfolio.

The U has set a goal of \$1B in research funding, with a focus on securing large-scale grants with societal impact.

# FORGE receives new U.S. Dept. of Energy grant

The Utah Frontier Observatory for Research in Geothermal Energy (FORGE) recently received just over \$7 million from the U.S. Department of Energy to continue its research. This funding is earmarked for critical next step activities in the creation of an Enhanced Geothermal System. Beginning in April, FORGE will be conducting a large, industry-scale stimulation to connect its injection and production wells.

### New rankings released today

Hot off the presses, U.S. News and World Report has released new official rankings. Some highlights:

- The full-time MBA program in the David Eccles School of Business rose 10 spots to an overall ranking of No. 38, and rose 8 spots to a public ranking of No. 15. The part-time program rose 4 spots to an overall ranking of No. 17, and one spot to a public ranking of 11.
- The S.J. Quinney College of Law received its highest ranking yet as No. 28 among all law schools and No. 11 among public law schools. The Stegner environmental program is also No. 7 overall, and No. 3 among public universities.

### **HS Academics**

- Graduating medical students at the Spencer Fox Eccles School of Medicine participated in nationwide Match Day on March 15, 2024. Students learned which specialties, and which hospitals or care centers, they have matched to for their residency training. Key Match Day stats from the University of Utah:
  - o 97.3% match rate
  - Students matched to 89 programs, in 24 specialties, across 34 states
  - 37 students matched into primary care specialties

38 students matched into Utah residencies

# Awards, Grants & Recognition

- Becker's Hospital Review named Mary Beckerle, PhD, CEO of Huntsman Cancer Institute and Associate Vice President of Cancer Affairs, one of 196+ women hospital presidents and CEOs to know in 2024.
- Deborah Yurgelun-Todd, PhD, was named a <u>Top Female Scientist in the U.S. for 2023</u>. By Research.com. She is a professor of psychiatry and associate director of the Mental Research, Education, and Clinical Centers for the Salt Lake City VA Health Care System. This is the second year in a row that she made the list, which is based on the number of peer reviewed publications and citations throughout the scientist's career: 424 publications and 33,647 citations in her case.
- Wendy Hobson-Rohrer, MD, MSPH, Associate Vice President for Health Sciences Education, was selected as Program Chair-elect for the Pediatric Academic Societies Meeting (PAS), the largest international academic gathering for pediatrics. This leadership role reflects her expertise and stature in the global community.
